2019-2020 Overall Rules

The following are the official contest rules for District 4-C4 2019-2020 and apply to all clubs wishing to participate. Contest participation is from April 1, 2019 through March 31, 2020

All information you wish to have considered for contest participation must be included on a District 4-C4 2019-2020 Contests Report, LCI Service Activities Reports (SAR/MAR), or other document. SAR/MAR and other document reporting must include all of the information requested on the Contests Report Form. PDF copies of SAR/MAR reports must be emailed to Contest Commissioner. Reporting on the contest reporting form is not necessary so long as all information requested on the Contests Report Form is included in the report. Each report should include only the activity for one month.

Reports, with all required validations, must be received by the Contest Commission Commissioner by the 7th of the month. Reports may be revised and submitted as needed but must be received by the Contest Commissioner no later than April 7, 2020. Reports/revision received after April 7, 2020 will **NOT BE CONSIDERED**.

Unless otherwise indicated on a specific contest, there are THREE (3) levels of Club competition for contests based on club size as reported on the 03/31/19 LCI Monthly Membership Report (MMR). Please see the following page for a list of clubs in each category. The membership categories are: clubs with 1 to 24 members, clubs with 25 to 49 members, and clubs with 50 members or more.

Unless otherwise indicated on a specific contest, points will be on a per capita basis – total contest points for a club divided by the number of members reported on the 03/31/20 LCI Monthly Membership Report (MMR).

Campaign events/fundraisers/club visitations for District, Multiple District, and/or International office are considered political and are not eligible for any contest.

All clubs must be in good standing and in compliance with Lions Clubs International (LCI) AND Multiple District 4 (MD-4) AND District 4-C4 as of April 15, 2020 with no financial balances due LCI or MD-4 to be considered for awards.

Please keep a copy of all reports and supporting information for your club records.

In all cases, the decision of the Contest Commissioner will be final.

Perpetual awards are the property of District 4-C4 and are on loan to the winning clubs from the time of the award until 12/31/19 and if lost or damaged replacement/repair is the responsibility of the club.

Rules

- Donations made by a Lion, Lioness, or Leo.
- Donations made by non Lions that are the direct result of solicitation for a Club sponsored blood drive.

Points

- 1 Each unit of blood donated
- 3 Each unit of apheresis donated
- 10 Each Club sponsored blood drive

In addition, one hour of Community Service will be credited for each unit of blood/aphaeresis donated at a non Lions Club sponsored blood drive or donated individually.

The time spent sponsoring a Lions Club Blood Drive should be reported and will be considered as community service.

Rules

Bulletins/newsletters published between April 1, 2019 and March 31, 2020 will be considered if received on or before April 7, 2019. Copies of all bulletins for consideration must be sent to the Lion Maryah Tucker at MaryahLTucker@gmail.com. Information contained in bulletin will be considered for Top Club Contest.

2019-2020 COMMUNITY SERVICE CONTEST

Purpose

To recognize and honor clubs for providing service and visibility to their local communities through the sharing of their time.

Recognition

Perpetual Award

The Lions Roar/Community Service - awarded to the club with the highest per capita points

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Community Service hours are those hours given back to the local community as a Lion for which you
 are not paid and are not political. Medical Mission hours are considered in the International Relations
 Contest.
- Presentations at Lions events are extremely valuable but are not community service.
- Activities that include fundraising should be reported as fundraising, not community service.
- Reporting must include the complete name of the organization with a brief description of the organization; a brief description of the service provided by the Lions in your club; and the total number of hours served by the Lions in your club.
- The time given as an officer of your club/District 4-C4, Committee Member/Contest Chair, while extremely important and valuable, should not be included as community service.
- Travel time and/or travel expenses to the activity/project should not be included.
- Attendance at your club meeting/activity or attendance at any fundraising event should not be included.

2019-2020 EYEGLASS COLLECTION CONTEST

Purpose

To encourage all Clubs to collect eyeglasses for recycling from local/community collection and from corporate sources.

Recognition

Perpetual Awards for Local Collection

Matt Boxer - awarded to the club with 35 or less members

Bob Rose - awarded to the club with 36 or more members

Perpetual Award for Corporate Collection

Macy Mak Chan – awarded to the club with the highest per capita points

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories for Local and Corporate Collections.

Rules

Only eyeglasses and eyeglass frames will be accepted for the contest with screening of the items made by the club prior to submission. Sunglasses will be accepted but must be separated from eyeglasses in clearly marked boxes with lids. Eyeglass cases will not be accepted. Two categories of collection will be considered – local and corporate.

Eyeglasses must be delivered to:

- An authorized representative of the Lions In Sight Warehouse, please provide a copy of receipt
- Other locations (i.e. clinic in Nicaragua, hospital in China, medical mission, etc.), please provide a copy of receipt
- District 4-C4 Eyeglass Collection will be scheduled for March 2020. Collection will be held at 31 Bepler Street, Daly City CA 94014-1002. Please deliver glasses in stackable boxes with lids/covers taped closed marked with your club name. **Boxes should not exceed 25# each.**
- Contest Commissioner will report your club's donations and will provide receipts upon request.
- Hours spent collecting glasses should be reported and will be considered as community service.

2019-2020 FAGIN CONTEST

Purpose

To encourage all Clubs to create good feeling and fellowship through the tradition of "borrowing" of club bells, gavels, and mascots.

Recognition

Perpetual Award

Fagin – awarded to the club with the highest number of points

Rules

- Only club bells, gavels, and mascots from District 4-C4 Lions Clubs are included in this contest; club banners are not included.
- "Borrowing" must occur between the official opening and closing of a regular club meeting only excludes all other events, i.e. club installations, social events, fundraisers, district, region, zone, council events, etc.
- Chaining down or otherwise anchoring club bells, gavels, and mascots does not prevent "borrowing".
- Without the residing club having a hand on club bell, gavel, or mascot the item is considered "borrowed" once it is touched by the "borrower"; residing club may "borrow back" the item if the visiting club leaves it unguarded.
- Residing club president must retrieve club bell, gavel, and/or mascot by visiting the "borrowing" club. The "borrowing" club may not charge ransom for the item but the residing club is subject to "borrowing" club Tail Twister practices.
- "Borrowing" club may not alter or damage borrowed items and must provide opportunity for residing club to retrieve items within 60 days at a regular club meeting or Lions event of their choice.
- "Borrowed" items must be retrieved prior to 03/31/20.

2019-2020 FUNDRAISING CONTEST

Purpose

To recognize and honor those clubs raising money and distributing funds to their local communities.

Recognition

Perpetual Award

The Lions Roar/Fundraising - awarded to the club with the highest per capita points

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Fundraising hours are those hours served at your club sponsored fundraising event for which your club's charity account receives the proceeds for local donations. Time spent volunteering at a fundraising event for which your club does not receive monies should be reported as community service. Attendance at a fundraising event should not be included as fundraising or community service.
- Fundraising Reporting must include a brief description of the club's fundraising project/activity including the date; the <u>NET</u> dollars raised. Please report only the hours that are spent working the event by the Lions in your club; <u>hours reported should NOT include time spent at the actual event as attendees</u>. Travel time to the activity/project should not be included.
- Grant applications for local projects are considered fundraising projects. Applications submitted should be reported in the month of submission; receipt of grant should be reported in the month the funds are received. Please include the name of the grantor in your description of the activity.
- Donations should include the name of the organization, a brief description of the organization, date of donation, and the donation amount. Donations should be reported in the Community Service section of the Contest Report.
- Donations made to District 4-C4, MD-4, LCI, and/or other Lions political fundraising activities should not be included.
- Monetary Donations received for and donated from your Club's charity account should be reported; In Kind Donations received should not be included. If using your SAR/MAR for this contest, please be sure to advise which donations received or made were In Kind.
- Funds raised and donated for international purposes will be considered only as part of International Relations Contest.

- 50 Each grant application completed and/or granted

2019-2020 HEARING CONSERVATION CONTEST

Purpose

To encourage all Clubs to raise funds for hearing conservation and collect and sponsor hearing aids.

Recognition

Perpetual Award

George Habeeb - awarded to the club with the highest per capita points

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Documentation/receipt must be provided for each hearing aid sponsored and/or collected.
- Hearing aids may be sent directly to Ear of the Lion, 850 San Jose Avenue, Suite 115, Clovis CA 93612 or they may be turned in with eyeglasses at District 4-C4 Eyeglass Collection. Please be sure to include your club name and address in the container with the hearing aids; Contest Commissioner will report your club's donations and will provide receipts upon request.

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Club Regular Meetings/Installations/Events, Club Charter Events, Council Meetings/Installations/Events, Club Fundraisers, Cabinet Meetings/Installations, District 4-C4 Events (includes region and zone Student Speaker Contests), Multiple District Events, and Lions International Events where all Lions are invited will be considered.
- Joint Club Meetings/Events will be considered if a signed visitation form is submitted for each participating
- Joint Council Meetings will be credited for the club's Council Area.
- Attending meetings where the Lion is an Associate Member of the club are not visitations
- Participation at another club's service project is not a visitation and should be reported as community service **by your club** if your help was provided at the event.
- Joint Ventures/Activities are not visitations.
- Hosting Council Meetings are not visitations for the hosting club.
- Signed documentation of each club visitation must accompany contest report. Documentation must include all
 of the information listed on the District 4-C4 Inter-Club Visitation Report form dated 04/01/18. A copy of
 confirmed registration/delegate form may be used for LCI and MD-4 events. Reports must be legible. Signed
 visitation forms are no longer accepted for District Events (Cabinet Installation, Cabinet Meetings, Region/Zone
 Meetings, District Trainings, District Student Speaker Contest, Multi-Club Installation, etc). Attendance will be
 reported to the Contest Commissioner based on checking in at the event as reported to the Cabinet Secretary
 following the event.
- Members of District 4-C4 Cabinet, Council Officers, and Lions campaigning for office are not eligible for visitation points while performing duties of office or campaigning; accompanying spouses/partners will only be considered when actually attending as a Lion not as a spouse/partner.
- Attendance at District 4-C4 Convention will be reported by Convention Committee. No visitation form is required.
- As a courtesy, please inform the club of a planned visitation and arrive at the meeting promptly.
- Attendance at Leo Club charter events/meetings are visitations; attendance at Leo Club activities are not visitations. Attendance by the sponsoring Lions Club at any Leo Club event is not a visitation.

Purpose

To recognize and honor clubs for providing service and visibility to international communities.

Recognition

Perpetual Award

Dr. Chang Wah Lee - awarded to the club with the most per capita points

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Twinning MUST BE with clubs outside the United Sates. A copy of the signed Official Lions Clubs International Twinning Resolution or application must be submitted.
- The name and country of each youth hosted/sponsored must be reported. The name, city, state, country, and district of a hosted visiting Lion must be reported.
- Community Service hours are those hours served outside United States as a Lion for which you are not paid and are not political. Reporting must include the complete name and location of the organization/community with a brief description of the organization; a brief description of the service provided by the Lions in your club; and the total number of hours served by the Lions in your club.
- Travel time to the service is not included.
- Fundraising hours are those hours served by the Lions in your club at a club sponsored fundraising event for which your club's charity account receives the proceeds for international donations. Reporting must include a brief description of the club's fundraising project/activity including the date; the net dollars raised; and the total number of hours served by the Lions in your club.
- Travel cost/time to the activity/project should not be included.
- Grant applications for international projects are considered fundraising projects. Applications submitted should be reported in the month of submission; receipt of grant should be reported in the month the funds are received. Please include the name of the grantor in your description of the activity.
- Donations should include the name of the organization/project, a brief description of the organization/project expense, date of donation, and the donation amount. Donations must be made through the club's charity account.

- 50 Attendance by a Lion from outside the United States at a Regular Meeting
- 250 Sponsorship of youth (ages 15-21) through Lions Youth Exchange
- 250 Hosting a youth guest (15-21) at a member's home through Lions Youth Exchange
- 50 Club Twinning outside of the United States
- 3 Each community service hour served by the Lions in your club
- 1 Each dollar raised for Club's international charity account
- 1 Each hour served raising international funds
- 1 Each dollar donated internationally.
- 50 Each grant application completed and/or received

2019-2020 INVITE A GUEST CONTEST

Purpose

Encourage invitation of prospective members to regular Lions Club Meetings/Events and District 4-C4 sponsored events.

Recognition

Perpetual Award

Fred Newman - awarded to the club with most per capita points

Rules

- The Invite A Guest Events must be at regular club meetings. The invited guest must be a prospective member; guests for the purpose of this contest may not be that specific Invite A Guest Meeting's guest speaker.
- Contest report must include the name of the guest(s) and the name of the sponsoring Lion(s).
- Club must produce some membership by the end of the contest year to qualify contest report must reflect the new member.
- When Invite A Guest guest is inducted, please include the date of the Invite A Guest activity on the contest report.
- Reported Invite A Guest Contest Events will be considered for the Membership Contest and do not have to be reported twice.

2019-2020 JOINT VENTURES/ACTIVITIES CONTEST

Purpose

To encourage Clubs to work together, both with other Lions Clubs in District 4-C4 and other service organizations, in various ways to build fellowship, strengthen membership, and develop a stronger sense of unity throughout the District.

Recognition

Perpetual Award

Ray Rosenthal - awarded to the club with the most per capita points

One first place certificate will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Joint Ventures/Activities are cooperative activities between service organizations that involve the planning and carrying out of the activity. Attendance at another organization function is not a Joint Venture/Activity.
- Other service organizations include (not limited to) Rotary Club, local Parent Teacher Associations, local Police Athletic Leagues, etc. so long as the organizations are working together for a common goal.
- Each participating Lions Club should report the venture/activity. Community Service Hours and Fundraising Hours should be reported by each participating club (do not total under any one club) following the specific applicable contest rules.
- Joint Ventures are not visitations.

- 10 Each participating Lions Club
- 5 Each participating club's branch and/or Leo club(s)

2019-2020 LIONS FIGHT HUNGER CONTEST

Purpose

To promote and encourage Lions to work toward the elimination of hunger.

Recognition

Perpetual Award

Denise Kelly – awarded to the club with the most per capita points domestically **PDG Esther Lee –** awarded to the club with the most per capita points internationally

One first place certificate for domestic and one first place certificate for international will be awarded to the club with the highest per capita score in each of the three Contest Membership Categories.

Rules

- Sponsoring a local food drive report the pounds of food collected and delivered to local food bank/agency
- Volunteer service provided at a food distribution agency (sorting food, distributing food, meal service, etc.)
- Monetary donations made to agencies providing free food made through your club's charity account
- Holiday Food Baskets report dollars spent and hours to shop, assemble and deliver the baskets
- Contest Commissioner will include this information for the Community Service Contest, the Fundraising Contest, Senior Activities Contest, Top Club Contest, Youth Outreach Contest, etc. where applicable --it is not necessary to "double report"

- 10 points per pound of food collected
- 25 points for each hour of service
- 1 point for each dollar donated through your club's charity account

2019-2020 LONG TAIL AMBASSADOR AWARD

Recognition

The District Governor will present recognition to each successful Lion

Rules

- Lions participating in this challenge must advise the Contest Commissioner of their intent no later than the First Cabinet Meeting of each year.
- A Lion must attend a regular meeting of every Lions Club that meets with regularly scheduled meetings within the geographical boundaries of District 4-C4.
- It is not necessary to have a signed visitation form from your Home Club.
- If you are an Associate Member of a club, please advise the Contest Commissioner when reporting
 your participation in this Contest.
- New Lions Clubs must be visited between their Charter Event and the end of the contest year.
- Please always inform the club of a planned visitation.
- District 4-C4 Cabinet Members performing duties of office are excluded.
- Signed documentation of each visitation must accompany contest report, please indicate Long Tail
 next to the name of the visiting Lion. The same copy may be used for the Inter-Club Visitation and
 Top Club Contests, duplicate copies are not necessary. Documentation must include all of the
 information listed on the District 4-C4 Inter-Club Visitation Report form dated 04/01/18. Reports must
 be legible. A visitation form is not required for the Lion's home club; it is assumed that there is
 regular attendance at club meetings.

2019-2020 MEMBERSHIP CONTEST

Purpose

To honor Clubs for pursuing ways to increase and retain membership.

Recognition

Perpetual Award

Don Stanaway - awarded to the club with the highest number of points

One first place certificate will be awarded to the club with the highest score in each of the three Contest Membership Categories.

Rules

- Contest Commissioner will track this contest based on MMR reporting.
- Deceased members will not be considered as part of net membership.
- Reported Invite A Guest Contest Events will be considered for the Membership Contest and do not have to be reported twice.
- New member orientation is not considered a membership event or program.

- 25 Net membership gain (03/31/20 MMR minus 03/31/19 MMR)
- 25 Each new member in a club chartered before 04/01/20
- 10 Each club sponsored membership event or program described in contest report.

2019-2020 SCRAPBOOK CONTEST - FORMAL

Purpose

To encourage Clubs to maintain a history of their year's activities via a scrapbook.

Recognition

One first place and up to two honorable mention certificates will be awarded based on the highest number of points. Winners to be announced at District 4-C4 Convention and certificates forwarded to winning clubs.

The first place winner will be entered into the MD-4 Scrapbook Contest; judging at the first Council of Governors Meeting after the International Convention.

Rules

- Please advise the Contest Commissioner no later than April 1, 2020 of intent to participate specifying formal or informal contest.
- Activities should include July 1, 2019 through June 30, 2020. Submission for District Contest includes July 1, 2019 through April 30, 2020. Winning scrapbook will be returned to club to complete year and return to Contest Commissioner no later than July 15, 2020 for submission to Multiple District 4 Contest.

- All event material should be kept together i.e. all July 4th activities in one category with all additional July activities in another category
- Scrapbook must be prepared Lions, not professionals. The skills and talents of any Lions may be used but no professionals may be hired except that commercial bindings may be used.
- Maximum cover size is 19"x25".
- The scrapbook shall be divided and consist of a title page and sections arranged in sequence shown in the Points section below. Each section is to be identified by a tabbed section divider. The title page must bear the Club Name, District, Region, Zone, the names of Club Officers and Directors and the Club Scrapbook Chair. The title page should not be tabbed. A plain fly sheet may precede the title page to protect it from abrasion. An un-tabbed table of contents may follow the title page.
- The only photos and illustrations to be considered in judging will be those telling the story of the project, event, etc. Other photos and illustrations may be used for judging on general appearance.
- Judges are visiting dignitaries attending annual District 4-C4 Convention.

Multiple District 4 has announced the creation of an electronic formal scrapbook. Details have not been announced and will be provided upon receipt.
